Resolved to Comment - The Parish Council have reservations regarding increased traffic on Gainsthorpe Road, especially at weekends, due to the effects on social and leisure activities at the Shires Restaurant, Bowling Club, Children's Playpark and the Fishing Lakes. Gainsthorpe Road is currently 40 MPH, however due to safety concerns for the patrons to the above establishments, the Parish Council requested a decrease to 30 MPH, which we were informed some TWO YEARS ago had been approved, but has not been implemented. WHY ?
